

Restricted to Centre Trial for solo drivers including Expert, A&B schoolboys, who are members of Clubs affiliated to the Wessex Centre ACU. Held under the NSC of the ACU, the Standing Regulations, the Wessex Centre Rules, the following Supplementary Regulations and any final instructions which have or may be issued.

1. OFFICIALS: Wessex Centre Steward – R. Burt; Club Steward - Frank Sweeting;

2. AWARDS: To be eligible for an Adult Award you must enter as and ride the Route specified for your current Wessex Centre Grading, To be eligible for a Youth Award you must enter as and ride the Route specified for your age Group. “A” Route: Errington Cup for Best Expert. Non “A” Route: H J Giddings Cup for Best 'A/B'; Bob Missen Cup for Best 'B', Trials Cup for Best 'C'. An award to the Best Over 40 and 50. All awards are subject to minimum of 3 entries in each class with the exception of the premier award. Runner up awards will be given if there is a minimum of 10 entries in the class, if there is over 15 entries in a class a 3rd award will be given, etc. Club cups are held for one year only.  
There will also be a class for Expert, A&B Class schoolboys. An award will be given to the winner in each class if there are three or more entries in the class.
3. ENTRIES: Adult £13 Schoolboy entry fee will be £10. Entries must be made on the form below and accompanied by the entry fee and sent to the Secretary of the Meeting at the above address. **Closing date - Wednesday 7th October.** All entries received after the closing date and up to 1 hour before the start will be accepted with an entry fee of **£20**. Club subscription £5. Cheques to be made payable to West Wilts Motor Club Ltd. One motorcycle to be ridden by one driver during the trial.
4. START: Upper Farm, Langridge Lane, Langridge, Bath BA1 9BX. First mans time 10.30 a.m. and the rest at 1 minute intervals.
5. TIES: If there is a tie, the driver with the most cleans will win. If there is still a tie, the driver to gain advantage will win.
6. COURSE: All on private land and consisting of a number of laps depending on conditions. On some sections there will be an easier route for 'A/B, 'B', 'C', Over 40 and 50 riders and to be eligible for their class awards, they must ride the easier route. Only riders riding their class defined route – main or alternative to qualify for championship points.
